## PRIVATE SECTOR SERVICE GO VIRGINIA REGIONAL COUNCIL 9

#### What is GO Virginia?

The Virginia Initiative for Growth & Opportunity in each Region or "GO Virginia" is an initiative to help generate private-sector growth and high paying job opportunities in all regions of the Commonwealth. GO Virginia is based on three main issues: 1) the state needs strong private sector growth and job creation; 2) effective collaboration among business, government, and higher education is essential to grow and diversify the state's economy; and 3) state government must provide incentives for strategic job-focused collaboration in each region.

#### How is GO Virginia funded?

The General Assembly initially allocated \$35.95 million for GO Virginia funding, including \$30 M in FY 2018 for project funding. GO Virginia funding increased by \$5 million in FY 2019 and \$10 million in FY 2020, for a total of \$29.5 million in FY 2019 and \$34.5 million in FY 2020.

#### What is Regional Council 9?

In 2017, nine Regional Councils were established to prioritize and facilitate projects that would best serve each region. Region 9, also known as the Piedmont Opportunity Corridor, encompasses eleven localities, including Charlottesville and the Counties of Albemarle, Culpeper, Fauquier, Fluvanna, Greene, Louisa, Madison, Nelson, Orange, and Rappahannock. The Region 9 footprint matches that of Planning District 9 and 10.

#### What types of projects are eligible for funding?

Proposed projects must address the opportunities outlined in each region's Growth & Opportunity Plan (Plan), in addition to state GO Virginia priorities. At least two localities must participate in each project. The Region 9 Plan specifies eligible project frameworks for targeted industries, as follows:

#### **Project Frameworks**

- Talent Development
- Innovation/Entrepreneurship
- Growing Existing Businesses
- Site Development

#### **Target Industries**

- Information Technology
- Food & Beverage Manufacturing
- Financial & Business Services
- Light Manufacturing
- Biotechnology

#### What is the Central Virginia Partnership's role with GO Virginia?

The Central Virginia Partnership for Economic Development (Partnership) serves as the support organization for the GO Virginia Regional Council 9. The Partnership, a not-for-profit public/private partnership, is the regional economic development organization for nine localities including Charlottesville and the Counties of Albemarle, Culpeper, Fluvanna, Greene, Louisa, Madison, Nelson and Orange. The Partnership's mission is to expand investment in a strategic, responsible and sustainable manner to provide career ladder jobs for the region's workforce. #### **Private Sector Member Requirements**

- Representation should include
  - o Small businesses (up to 50 employees)
  - Large businesses (50+ employees)
  - o Entrepreneurs
  - o Innovators in growing industries
  - o Experienced professionals
- Leadership/management experience required (five or more years in private business)
- \*Only Region 9 Chambers of Commerce may nominate private sector business persons to serve on the Council for these designated seats, when open.
- \*\*At-large nominations are solicited from the public for At-Large Private Sector Seats. Local business organizations and business leaders may nominate other business leaders. Self-nomination is welcome.

#### Council Member Terms

Unless a seat is vacated mid-term, there is a three year term commitment that begins on July 1. Vacancies are filled for the unexpired term.

#### **Time Commitments**

In order to impact and serve the entire region, regular attendance and consistent engagement is expected. There are typically up to seven meetings scheduled per year at locations throughout the region. Meetings are typically scheduled for a two hour duration. Each member also serves on a Task Force Group. (Sites, Talent Development, Growing Existing Business, or Innovation/Entrepreneurship) Each Task Force is responsible for supporting strategy in their frameworks and reviewing related project proposals. Additional service hours may be required if serving on the Nominating or Executive Committees.

All Council Members are required to register and view an online training session about the Conflict of Interest Act within 30 days of accepting an appointment on the Council. Filing of economic interests is not required for Regional Council members, unless individual members are otherwise required to do so.
