### **MINUTES**

### 1. Welcome

Jim Cheng opened the meeting at 11:00 am. Jim Cheng stated that the meeting was being held electronically via Zoom video and call-in due to the State of Emergency declared by the Governor.

### 2. Roll Call

At Jim Cheng's request, Shannon Holland completed a roll call of members. All members were present.

### 3. Public Comment\*

Jim Cheng stated the meeting had been publicly noticed and a public comment form was made available. All public comments were to be emailed by 7 am today. Shannon Holland stated that no public comments had been received.

### 4. Approve Minutes from Prior Meeting

Jim Cheng

Tom Click made a motion to approve the Meeting Minutes as presented. Ray Knott seconded the motion. The motion carried.

### 5. Review Project Pipeline and Available Funds

Jim Cheng asked Shannon Holland to provide updates on the Project Pipeline and available funding. Shannon Holland noted the following:

- Project Rebound and Project Reconnect were both approved and would advance to contract next week
- CBIC is still planning on applying for a FAST ACCESS application
- The materials enclosed should be updated to note that based on Strike Force feedback from last week, the Crafting a New Normal team revised their application and submitted for \$44,000. The Business Gateway team didn't think they could do the project for that amount and submitted a revised application for \$60,000. After consulting with the Chair and Vice Chair, it was decided that the Business Gateway proposal was not responsive to Strike Force feedback and was therefore not included in these meeting materials.
- Total remaining ERR FAST ACCESS funds in Region 9 is \$120,500. If the Crafting a New Normal proposal was approved today, there would be \$76,500 of funds remaining.

A brief discussion ensued about the number of grants that might be awarded with the remaining funds as well as the optimizing administrative efficiency by considering the size of grants.

After the update, Jim Cheng asked if there was any discussion on the Business Gateway proposal. No discussion was offered.

### 6. Approve Proposal Revisions, if any

Jim Cheng stated if there were any updates to the Crafting a New Normal proposal since meeting materials were circulated. Shannon Holland said that she verified with the applicant that funds would not be used for direct to consumer marketing and that would be stipulated with any proposal submitted to DHCD, if the Strike Force approved today.

Ray Knott made a motion to approve the proposal based on the update presented. Tom Click seconded the motion. The motion carried. Pace Lochte abstained.

### 7. Approve ERR and ECB Application

Jim Cheng noted that no new projects were submitted for approval.

### 8. Other Business - Limited to Emergency Items Only

Jim Cheng asked if there was any other business. None was offered. Jim Cheng then reminded the group that the Strike Force Committee would be a discussion item on the Annual Meeting Agenda as stipulated at the last Council Meeting. Jim Cheng asked if there was a volunteer willing to provide an update on the Strike Force Activities at the Annual Meeting. Ed Scott volunteered.

9. Adjourn Jim Cheng

Ed Scott made a motion to adjourn the meeting at 11: 19. Ray Knott seconded the motion. The motion carried.
