#### **MINUTES**

#### 1. Call to Order

Ray Knott, GEB Task Force Chair, called the meeting to order at 8:00 AM.

Roll Call

A roll call was performed. A quorum was established, as noted above.

Public Comment

There was no public comment submitted before the meeting or offered at the meeting.

#### 2. ACTION ITEM: Consent Agenda

- Meeting Minutes, April 12, 2024
- Meeting Minutes, January 25, 2025

Brian Cole made a motion to approve the minutes of the April 12, 2024, and January 25, 2025 meetings, as presented. Françoise Seillier-Moiseiwitsch seconded the motion. The motion carried.

#### 3. Update:

• Region 9 Grow Existing Business Projects Dashboard

Referring to the GEB dashboard in the meeting packet, Shannon Holland noted that since the last meeting, the Wine Industry Planning Grant closed and the Wine Industry Implementation Grant was awarded. The Wine Industry Implementation Grant contract is in process with an effective date of March11. Project VITAL contract has also been finalized. Both projects are just beginning with no issues, hence the greenlight status in the dashboard.

#### 4. Proposal Review

- Innovation Corridor Roadmap Planning Grant Summary
- Discuss Project and Scoring Rubric
  - o Shannon Holland noted the following updates to the Innovation Corridor Roadmap proposal.
    - A Match Commitment Form from Orange County has been received.
    - Letters of Support from Euro Composites and Afton Scientific have been received.
    - Shannon Holland also summarized responses to questions presented during the scoring

process including:

#### A. IMPACT

- Question: Can you provide a stronger vision for an implementation grant?
- Answer: To our knowledge this type of study has not been done in our region. We
  have studied sectors but not the intersection of those sectors to identify unique
  advantages. We expect the grant to identify high-potential innovation-driven
  opportunities and provide recommendations for action items that can be
  implemented by GO Virginia and other funding sources.

#### **B. REGIONAL COLLABORATION:**

- Question: How were participating localities engaged?
- Answer: Discussions were held with all localities in Region 9 over the past several months. All localities support and will benefit from the data being reviewed for the entire region.

#### C. READINESS:

- Question: Has the consulting firm been identified? Are they qualified?
- **Answer:** The consulting firm, TEConomy, has been identified and is qualified, with extensive experience.
- **Question**: Will other private sector companies be engaged and will they have a role and can they be involved outside of the advisory board?
- **Answer:** Local economic developers will help connect to more private sector companies. Private sector companies beyond those listed will be engaged through interviews, focus groups, and other activities.

#### Feedback from the GEB Task Force included:

Francoise Seillier-Moiseiwitsch asked who is serving with an AI/Data Science background. Shannon Holland responded that UVA's Alex Gates, Associate Professor of Data Science, is serving this role.

It was discussed that TEConomy had experience in Virginia and Region 9. They had completed extensive innovation work for GO Virginia in 2018/2019 and were currently contracted with the TPI grant. TEConomy had also done similar projects and were selected from three strong candidates.

Overall, the task force was supportive of the project, but extensive discussion occurred around reducing proposal ambiguity and strengthening the private sector's influence. The Task Force wants to see private sector stakeholders on the Steering Committee or more robust engagement of the Advisory Committee to ensure adequate private sector influence. The Task Force suggests a deliberate cross-section of geographic and sector representation. If private sector companies cannot commit to the Steering Committee commitments, there needs to be a mechanism for having them inform the process in a meaningful way, as the committee is currently very heavy Economic Development. Practical experience is needed to yield a better work product, and more ready implementation grant.

Shannon Holland will discuss with the applicant team and deliver responses to the task force quickly so they can re-score the proposal before the Council Meeting.

#### 5. Growth Plan Feedback

• 2025 Growth Plan – Cluster Scale Up Assessment by Sector Shannon Holland gave a presentation. [Presentation is posted with these minutes at <a href="https://www.GOVirginia9.org">www.GOVirginia9.org</a>.] The Growing Existing Business (GEB) Task Force was requested to assess the

impact that GEB-focused grant awards have had on each target sector by selecting a color from the stoplight spectrum to indicate the level of success achieved so far. After engaging of all the Task Forces, the results will be reviewed at the August Council meeting. DHCD's Cluster Based Economic Development Model was used to quickly evaluate progress and guide future priorities.

The Task Force was overall in agreement with the suggested assessments for the Cluster Scale Up strategy. They offered additional feedback including:

- Food & Beverage: There is an overarching concern for talent development, and they are curious of the influence current projects and Virginia Wine Coalition will have. In general, the sector and the region lack a talent-driver in this area.
- Finance & Business Services: Talent remains an issue, especially as return to office patterns
  continue, and employees refuse to relocate resulting in exits. CPAs, bankers, attorneys and similar
  occupations all have major shortfalls. Moreover, there is an issue with how data excludes a subset of
  jobs, like banking, where the industry relies on recruiters rather than posting jobs (posted jobs are
  what is captured for data).
- The Virginia Chamber is in the middle of its assessment which includes how AI will impact the state economy. Roque Castro is the Region 9 representative on that. There is an opportunity for a proposal on how AI will reshape our region's jobs. For example, software developers, something that has historically been a need, may no longer be applicable due to AI. From a Council recruitment perspective, it may be helpful to get someone in from that field.

The Task Force suggested a trend line be added to the graphic that corresponds with whether there is progress (green) or decline (red).

#### 6. Project Pipeline

- Talent Development TPI Planning should lead to talent implementation grants
- Growing Existing Business Innovation Corridor Roadmap, if approved, should lead to implementation grants
- Entrepreneurship REI and the Food & Beverage Business Accelerator grants should both lead to implementation grants

#### 7. Other Business

No other business was presented.

#### 1. Welcome

Tom Click called the meeting to order at 12:32 p.m. He announced that this meeting was all-virtual as allowed by the Governor's statement of an emergency due to the snowstorm. Tom Click shared that Council Chair, Ethan Dunstan, asked him to serve as Sites Task Force Chair until the next Annual Meeting, when a new chair will be nominated. Tom noted that today's meeting was a first step in increasing council engagement as discussed at the October Council Meeting. .

Roll Call

A roll call was performed. A quorum was established, as noted above.

Public Comment

No public comment was submitted prior to or offered during the meeting.

#### 2. ACTION ITEMS

Approve Meeting Minutes

Rob Archer made a motion to approve the Minutes as presented. Ethan Dunstan seconded the motion. The motion carried. Pace Lochte abstained.

#### 3. Update:

GO Virginia Program – Dashboard

Shannon Holland gave a brief overview on the new GO Virginia Program impact dashboard, noting the data presented is for closed projects only. <a href="https://public.tableau.com/app/profile/virginiadhcd/viz/GOVADashboard">https://public.tableau.com/app/profile/virginiadhcd/viz/GOVADashboard</a> 17345526597 200/GOVADashboard.

#### Region 9 Entrepreneurship Projects Update

A draft dashboard for the Entrepreneurship Task Force was provided in the meeting materials. Shannon Holland noted that it will be refined over time, but it has been created with the goal of communicating with task forces on related activities and success. The Status stoplight on active projects is an effort to highlight areas that may need members' attention. Shannon provided these highlights:

- Carver Food Enterprise is green because it has extended its contract to get more people involved to reach goals and metrics.
- Rural Entrepreneurship is yellow because there are concerns that the project is not focusing on target sectors and we have questions about transparency with staff.
- REI is orange because the project is not on track to deliver what the Council needs. Shannon Holland has participated on the planning committee with direct feedback on consultant selection, report content, and recommendations. Her feedback has not been heeded and isn't reflected in the deliverables. The report was presented to the Council in October but the Action Plan was not delivered at that point. Shannon has most recently been working to develop a strong deliverable to ensure we get good solid implementation grants from this planning grant. DHCD shares similar concerns, and they have already been brought in to help.

#### 4. Regional Entrepreneurship Initiative (REI) - Deliverables

Shannon Holland met with the Venture Central Team and DHCD staff to react to the Action Plan proposed in early December and enclosed in the meeting packet. Highlights included:

- The recommendations should first be validated with entrepreneur vs entrepreneurship support organizations
- The action plan should demonstrate more clarity of assets already in the eco-system and what they are delivering and how they will be involved (Lack of asset map, e.g. omitting CvilleBioHub)
- The report conflates start up ecosystem and scale up (GEB) efforts is the council okay with this and if so, should it be delineated in the action plan
- Action items should focus on Region 9 target traded sectors/ high growth traded sector
- Recommendations:
  - # 1 & 2: Clarify why this is needed to catalyze efforts; Rec. 1 might be feasible if led by entrepreneurs vs ESOs; and 2 could be a subcommittee but it doesn't seem feasible that this infrastructure can be maintained and needed for target sectors in each county, especially if focused on target traded sectors
  - # 3: seems most aligned with GO Virginia but needs clarity on how it aligns with existing/prior GO Virginia efforts and/or can't be duplicative of SBDC programming. It must be tailored for needs of our region
  - # 5: not a fit; VCW P could lead something like this already; youth e-ship training is too far from cash register and is workforce development
  - # 6: assumed this would be a core part of the plan itself; it's important so why wasn't
     it discussed in terms of asset mapping; a small effort might be included
  - # 7: Is in line with GO Virginia but report didn't outline what is or has been done in this area so there are no specifics as to what should be happening next, i.e. post federal grant just completed with is next?
  - # 8: Does a technical education effort lead to job candidates for employers? Needs to be validated by the sector leaders as some of the training listed received pushback from employers representing the sector. This isn't a finding of the report, but more an action-item that puts them in the workforce development space. Also seems it needs to be parsed out between beginner and growth employers.
  - # 9: GO Virginia can support some outreach efforts as far as programming, but not generalized economic development marketing.

Pace Lochte asked what happens if the project team doesn't revise this report. Shannon Holland shared that in Northern Virginia, the REI project submitted a subpar report and DHCD rejected that and made them rewrite it. Secondly, these planning grants are supposed to point Council toward promising implementation grant opportunities, and that would be lacking. Ethan Dunstan added concern for the amount of time staff has spent working with the team without that feedback being implemented, and the need for Task Force involvement earlier in the process to leverage staff's position.

#### Next steps: Based on feedback, Shannon Holland will:

- Complete validation of the report by entrepreneurs
- The Council could decide at its next meeting to accept or reject the report and action plan. Tom Click mentioned using the current "no" votes to push for revisions.
- Address high-growth traded sector entrepreneurs in the action plan.
- Inform the project team that they are flagged as "red light" on our dashboard.
- Hold an in-person meeting to discuss feedback from the Task Force and DHCD and emphasize urgency for revisions. Tom Click agreed to join.

#### 5. Feedback from Task Forces

Shannon Holland requested feedback and ideas for improving council processes to engage more closely in project development and review, including how to involve task force members earlier, allowing time for questions and feedback on proposals? Ethan Dunstan said that having Task Force Chairs should be helpful in getting earlier feedback on proposals in order to get to go/no-go sooner, before staff and Council members expend considerable time.

#### 6. Project Pipeline

The REI Action Plan was expected to provide leads to fill the pipeline. Pace Lochte suggested sharing project ideas from other regions as way to develop new project ideas. This could be done at task force meetings or council meetings.

#### 7. Adjourn

The meeting was adjourned at 1:30 p.m.

The Regional Entrepreneurship Initiative (REI) "Thrive in Place" Report identified critical gaps in our entrepreneur ecosystem. REI FUEL (Framework for a Unified Entrepreneurial Landscape) implements key recommendations to catalyze economic prosperity across Region 9's localities through three components:

- **FUEL Coalition** (Recommendation #1) establishes a region-wide coalition of business and government leaders to coordinate support for GO Virginia target sectors, creating unified goals and cross-communication capability.
- **FUEL Connection** (Recommendation #3) convenes c-suite leaders from traded sector companies in facilitated peer forums, with specialized programming for manufacturing and dual-use companies in response to demand.
- **FUEL Capital** (Recommendation #7) reduces capital access barriers through banker education, sector-specific CEO/CFO capital education programs, and ambassador engagement in wealthy communities to connect accredited investors with local opportunities.
