I. INTRODUCTION

GO Virginia is a bipartisan, business-led economic development initiative that is changing the way the Commonwealth’s diverse regions collaborate on economic and workforce development activities. The goal of the GO Virginia program is to foster traded sector growth and job creation through state incentives for regional collaboration.

This report is prepared annually for the Region 9 Council to review at their Annual Meeting in June of each year. The purpose of this report is to summarize activities and milestones accomplished during fiscal year 2025 from July 1, 2024 to June 30, 2025 (FY25). These activities are designed to incentivize collaboration between business, education, and local government to drive the creation of jobs in specific target traded sectors.

GO Virginia Region 9, also known as the Piedmont Opportunity Corridor, includes the City of Charlottesville and the Counties of Albemarle, Culpeper, Fauquier, Fluvanna, Greene, Louisa, Madison, Nelson, Orange, and Rappahannock.

The GO Virginia Region 9 Council oversees the development and execution of the GO Virginia program within Region 9, including the development and evaluation of funding proposals. The Central Virginia Partnership for Economic Development (CVPED) serves as Region 9’s fiscal and administrative support organization. The Virginia Department of Housing and Community Development (DHCD) is the state agency responsible for administering the GO Virginia program.

The [2024 Region 9 Growth & Diversification Plan Update](#) (Growth Plan) listed available grant funding opportunities during the evaluation period in Region 9. Funding proposals were expected to drive one of these opportunities, strengthen and diversify the regional economy, while also focusing on one or more of Region 9’s target sectors employing at least one of four project strategies (see table below):

II. GROWTH & DIVERSIFICATION PLAN

As mentioned, this report is intended to demonstrate the progress of the Region 9 Growth Plan. The Growth Plan is updated every two years and can be viewed at www.GOVirginia9.org.

In FY 2025, the Region 9 Council approved five grants: BioBridge Talent Pathways Initiative (TPI), Food & Beverage Business Accelerator, Innovation Corridor Road Map, Rivanna Futures, and Wine Industry Implementation Grant. The first three projects listed are planning grants intended to result in implementation grants based on the plans developed. The last two grants are implementation grants aimed at achieving committed outcomes over the next several years.

These five projects advanced nine of the sixteen opportunities in Region 9's Growth Plan under the Growing Existing Business, Sites, and Talent Development project strategies. No projects were advanced under the Entrepreneurship strategy this year because the Council is waiting for an implementation proposal from the Regional Entrepreneurship Investment (REI) planning grant, which is concluding soon.

The specific grant opportunities advanced this year through these new projects are organized below by the related strategy.

- **Talent Development**
 - Drive target sector talent pathways planning efforts as described in the Region 9 Request for Letters of Interest for the Talent Pathways Initiative (TPI) planning grants.

III: SUMMARY OF PROJECTS AWARDED

As previously mentioned, the Region 9 Council approved five project proposals that were then submitted to and approved by the Virginia Growth and Opportunity (GO Virginia) Board, totaling \$1,282,095 from GO Virginia funds. Both projects also secured more support from local government, higher education, private industry, and other sources amounting to \$2,556,317 in matching funds and \$525,000 of added leverage.

The following project descriptions explain the planned activities and outcomes/deliverables under contract for each new project:

BioBridge Talent Pathways Initiative (TPI): Led by CvilleBioHub (CBH), this planning grant focuses on strengthening the Biotechnology & Biomedical sector in GO Virginia Region 9 by identifying future talent pathways to meet sector employment demand. The project goal is to develop a plan for building a robust talent pipeline that can meet the diverse workforce needs of biotechnology companies at all levels across the region.

The BioBridge TPI team will work with a consultant to: 1) develop an industry coalition, 2) complete a situational analysis, 3) conduct a gap analysis of workforce needs, 4) identify skills and training needs 5) map assets, and 6) develop strategies for future pathways projects. The deliverable for this project is a three-to-five-year action plan aimed at building a biotech-ready regional workforce. The action plan is expected to drive an immediate and subsequent implementation grant.

Innovation Corridor Strategic Roadmap: This grow existing businesses planning project led by Central Virginia Partnership for Economic Development and UVA will take a deeper dive into the region's industries to identify areas where the region has a global strategic advantage and new growth opportunities. Specifically, the focus will be across the domains of life sciences/biotech and digital/IT (data science, AI, autonomy, advanced materials, cybersecurity) with commercial and national security applications. The deliverable will be a report that will include recommendations and an action plan. The action plan is expected to drive an immediate and subsequent implementation grant.

Food & Beverage Business Accelerator Planning Grant: This grow existing businesses planning project led by Venture Central aims to support existing small to medium-sized food businesses, enhancing their ability to scale-up, create higher-paying jobs, and increase out-of-state revenue by evaluating the need for and design of an accelerator for Region 9. The accelerator will target established companies seeking resources and expertise to scale. The project will foster collaboration among local businesses, existing resource providers, higher education, local governments, and regional agriculture to create a comprehensive program designed to



maximize economic impact and ensure sustainable growth in the food and beverage manufacturing sector.

The project deliverable is a strategic plan that includes: a review of best practices from similar programs across the country, verification of potential demand for programming, an operational plan for the accelerator, identification of partnerships for the accelerator, a strategy for sustainability, and an action plan for next steps to bring the accelerator to fruition, if report validates demand.

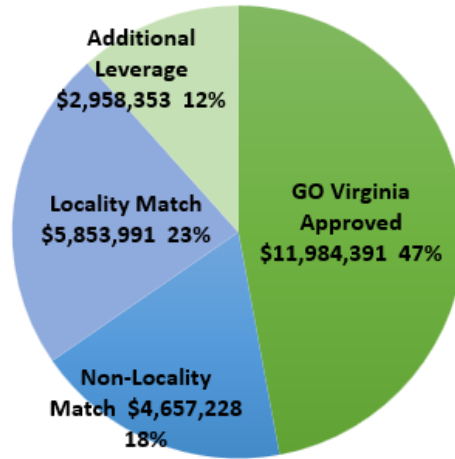
Rivanna Futures: Albemarle County leads this sites project to support design and permitting activities to advance 50 acres of the Rivanna Futures project from Tier 3 to Tier 4 on the business readiness site scale for Phase 1. GO Virginia funds will support design and permitting, as well as provide leverage for additional state and federal grants for additional phases. This site could add more than 850,000 SF of Light Industrial/Office space and new jobs in Intelligence, cybersecurity, biotech, geospatial, and advanced manufacturing, with an annual income above the prevailing median wage.

Wine Industry Implementation Grant: Led by Nelson County, this growing existing businesses implementation project will advance 10 of the 25 recommendations made in the Wine Industry Planning grant report, funded in 2024 by GO Virginia. The Region 9 footprint includes over 104 wineries and vineyards, an integral part of the Food and Beverage Manufacturing cluster. In 2023, wineries employed over 1,266 people with a location quotient of 10.47. The 2022 Commercial Wine Grape Report indicated that of the 5,000 acres of vineyards planted in Virginia, about 2,186 acres are located within 7 of the 10 counties in GO Virginia Region 9. According to the Region 9 Wine Industry Report, only 22% of the region’s wineries sell out of state, with only 3% of their sales in the traded sector.

The funds will advance the goal of building a sustainable organization that will strengthen this industry and drive exports across state lines. Activities include: 1) establish a private sector-led coalition of industry professionals and organizations to oversee the initiative 2) hire a professional to support implementation efforts; and 3) deliver sector-specific businesses services. The applicant team has committed to the following project outcomes: 1) 20 jobs created, 2) 25 business expanded (export across state lines), and 3) 104 businesses served.

With the addition of these newly awarded grants, through FY 2025, the Region 9 Council has awarded \$11,984,391 to 33 projects in the Piedmont Opportunity Corridor that will grow the regional economy through target traded sectors. Project teams have raised \$5,853,991 of support from local governments, \$4,657,228 from other sources, and \$2,958,353 additional leverage. This data is represented on the following chart:

Through June 30, 2025

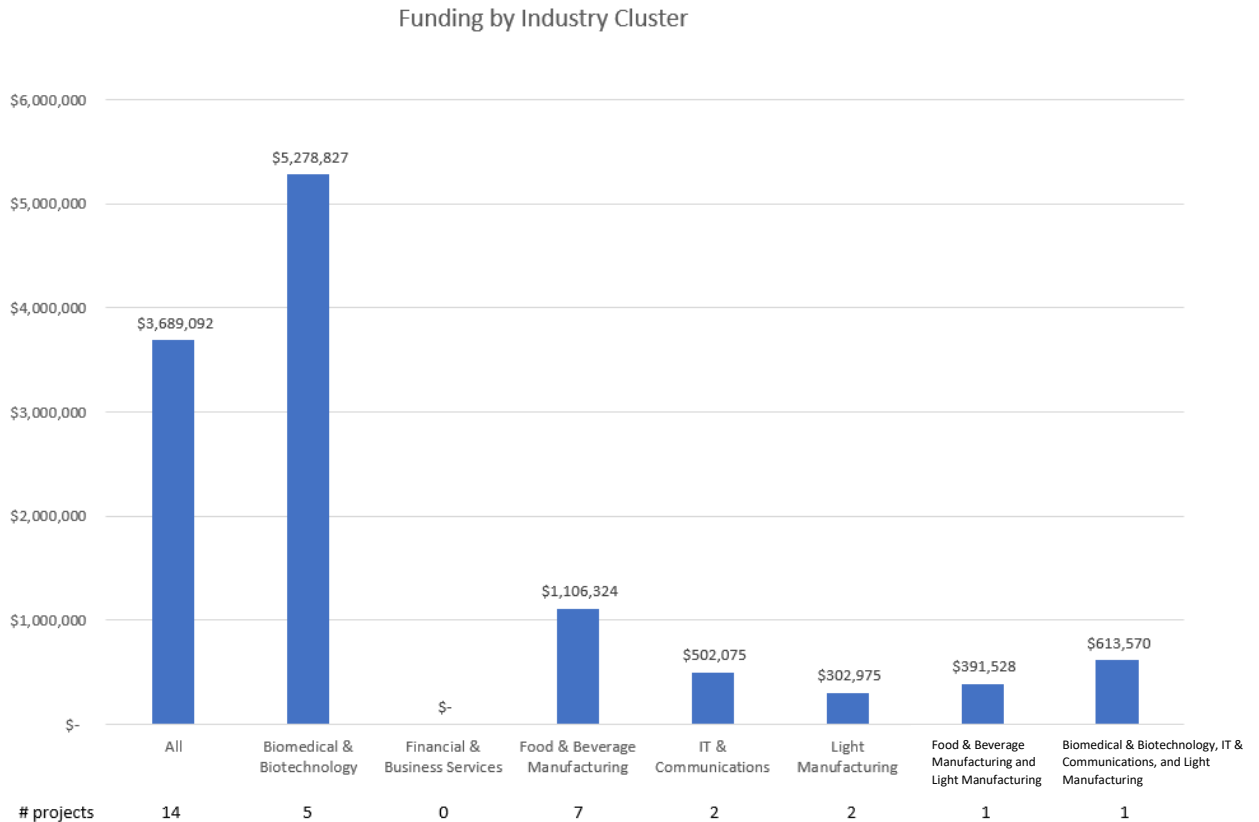
■ GO Virginia Approved ■ Non-Locality Match ■ Locality Match ■ Additional Leverage

IV: REGIONAL COLLABORATION & PARTNER SUPPORT

Developing projects requires significant effort in collaboration building. The Council has engaged either directly or through projects with at least 145 partners including: 87 businesses, 13 education institutions, 16 government entities, and 29 other non-profits or stakeholder organizations. A list of those organizations is included at the end of this report.

In addition to grant development, the Region 9 Council and staff have engaged in various other activities:

10. Participated in monthly GO Virginia Organization Support meetings.
11. Attended the GO Virginia Board Retreat with Chair in Danville.
12. Participated in and hosted the GO Virginia Regional Staff Retreat in Charlottesville.
13. Participated in DHCD Policy and Outcomes Feedback Sessions.
14. Attended Virginia Economic Developers Association (VEDA), Charlottesville Business Innovation Council (CBIC), CvilleBioHub, Tom Tom and other community events.
15. Collaborated with peer regions in sharing knowledge to help drive project pipelines statewide.

V: OUTCOMES AND IMPACT

The benchmark for the GO Virginia program is Average Annual Wages as measured in the first quarter (Q1) of each calendar year and sourced from Chmura JOBS EQ. As noted below, as of 2024Q4 Average Annual Wages in Region 9 are \$63,093 and \$75,076 in Virginia. Average annual wages per worker increased 2.7% in the region over the preceding four quarters as compared to 5% for Virginia.

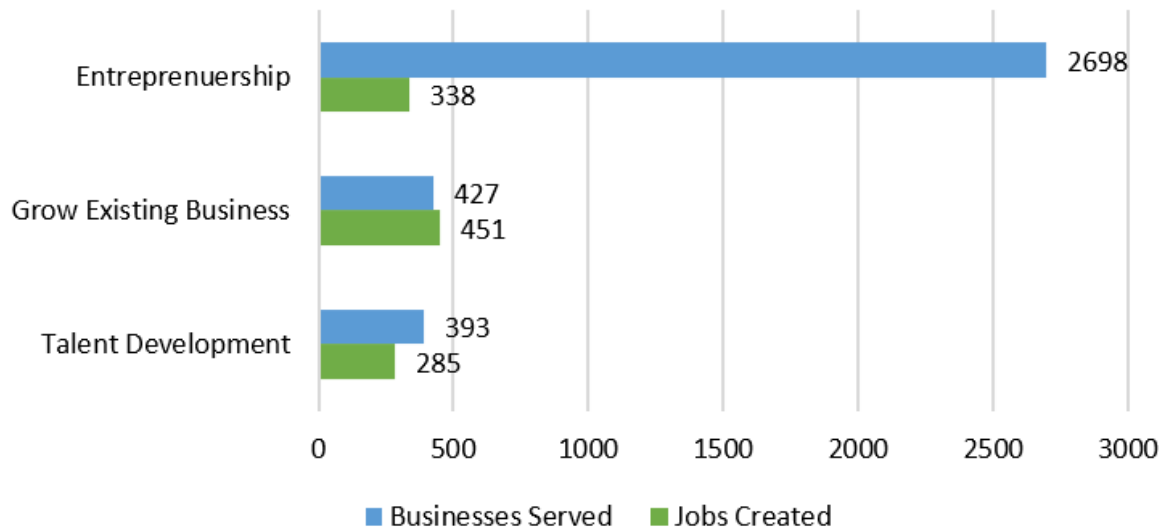

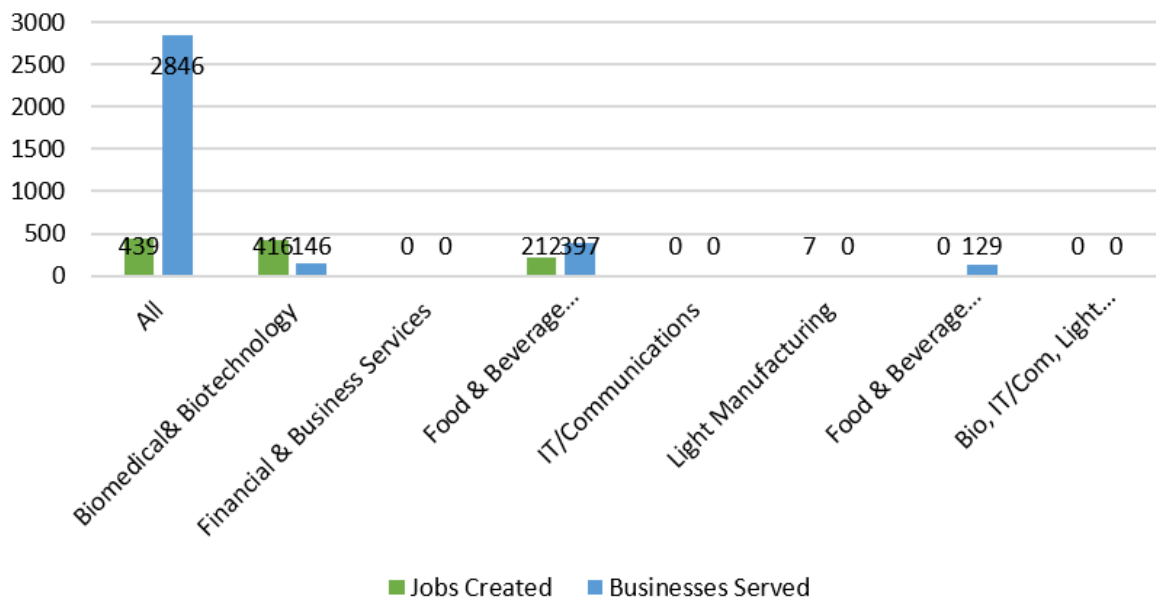
Outcomes by Strategy

VI: COMMUNICATION AND OUTREACH

The Region 9 Council website, www.GOVirginia9.org, is a primary resource for stakeholders. Regional staff also provide updates through email lists, Constant Contact newsletters, and LinkedIn.

In FY 2025, Region 9 staff continued to market the GO Virginia program and worked hard to support active grant leaders. Staff often went to stakeholder meetings and outreach events. The Region 9 staff also stayed in touch with regional economic development partners to learn about their activities and to explore ways to work together.

The Region 9 Linked In page continues to grow and now has 484 followers. The Infographic developed in 2024 is updated quarterly and provided as an impact report to Council and on the website.

The Council is developing the 2025 Growth & Diversification Plan for publication in fall 2025. This effort is being undertaken in-house with staff support.

VII: PROJECT PIPELINE

During FY 2025, staff invested considerable time cultivating projects and engaging stakeholders. As noted in this report, five of those project ideas were developed, submitted, and approved.

In the coming year, the Council expects to support and review proposals from the four active planning grants including: BioBridge TPI, Food & Beverage Business Accelerator, Innovation Corridor Roadmap, and REI. Additionally, there is interest in developing additional sites projects.

Staff will support project teams by joining advisory committees for grants and regularly updating economic development leaders about the pipeline to manage potential match commitment requests.
