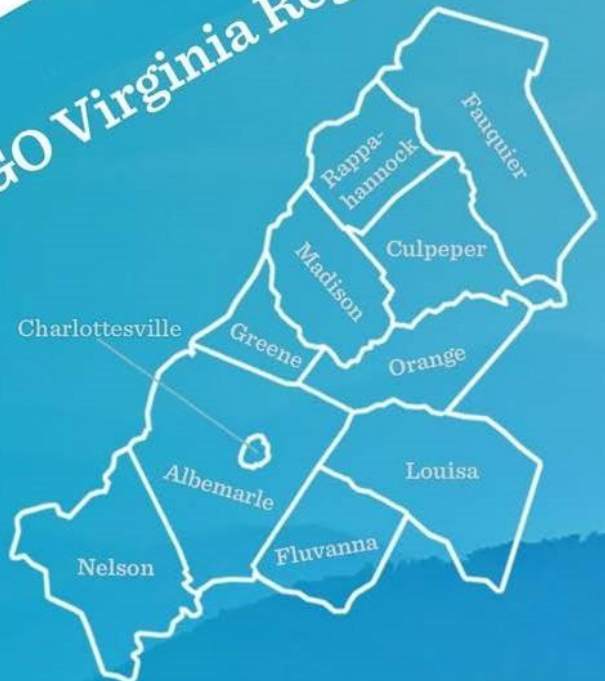

## INTRODUCTION

GO Virginia is a statewide, bipartisan, business-led economic development initiative that promotes collaboration among local governments, higher education, industry, and workforce initiatives. **The program goal is to create high-paying private sector jobs by awarding grants for regional priorities across the Commonwealth.**

**This report is prepared annually for the Region 9 Council to review at their Annual Meeting in June of each year.** This report summarizes regional milestones and accomplishments that advanced the program goal during Fiscal Year 2026 (July 1, 2025 - June 30, 2026).

GO Virginia Region 9, also known as the Piedmont Opportunity Corridor, includes the City of Charlottesville and the Counties of Albemarle, Culpeper, Fauquier, Fluvanna, Greene, Louisa, Madison, Nelson, Orange, and Rappahannock.

The GO Virginia Region 9 Council oversees the development and execution of the GO Virginia program within Region 9, including the development and evaluation of funding proposals. The Central Virginia Partnership for Economic Development (CVPED) serves as Region 9’s fiscal and administrative support organization. The Virginia Department of Housing and Community Development (DHCD) is the state agency responsible for administering the GO Virginia program and supporting the GO Virginia Board.

## GROWTH & DIVERSIFICATION PLAN

The [2025 Region 9 Growth & Diversification Plan](#) (Growth Plan) was published in October 2025. The target sectors from the 2023 Growth Plan update were reaffirmed as representing the best opportunity

for regional high-wage job growth. The plan sets forth twenty [Growth Plan Opportunities](#) for grant funding that could advance the GO Virginia program goals in Region 9. As stated in the plan, grant proposals must focus on one or more of Region 9’s target sectors while deploying at least one of the four programmatic project strategies as noted in the table below:

Projects advancing the Region 9 Growth Plan may be funded through the Region 9 Per Capita Fund or through the Statewide Competitive Fund. Competitive Fund projects can be inter-regional, involving two or more regions, or single-region when project costs exceed a region’s available per capita funds.

## SUMMARY OF PROJECTS AWARDED

In FY 2026, the **Region 9 Council approved or actively supported three new projects toward funding or implementation** that advanced **nine of the twenty** opportunities identified in the Region 9 Growth Plan.

***Expanding the GO TEC Career Pathway in Region 9*** is an implementation project that will expand the [GO TEC](#) (Growth Opportunities in Technology Careers) model into all middle schools in Charlottesville City Schools, Albemarle County Public Schools, and Greene County Public Schools. The program, led by Albemarle County Public Schools, will train 3,126 middle school students and create seven program labs.

This project will advance three Talent Development opportunities.

***Food & Beverage Accelerator*** is an implementation grant that will advance planning grant recommendations for Food & Beverage production companies primarily in the Counties of Albemarle, Fauquier, Madison, Nelson and Orange, as well as the City of Charlottesville. Led by Venture Central, the program will expand sixteen businesses through a cohort model and raise \$150,000 over the two-year grant period.

This project advances two Grow Existing Business opportunities.

***AI Mobile Unit for Workforce & Education*** is an inter-regional competitive implementation project led by Cyber Bytes Foundation in GO Virginia Region 6, also serving the counties of Fauquier, Nelson, and Orange in Region 9. This project will address vulnerabilities identified in [Virginia AI Workforce and Education Landscape Assessment \(AISLA\)](#). It targets lagging workforce readiness for AI integration and inequities to AI education, primarily in rural areas. Grant activities will deliver AI literacy, ethics, prompting, and industry-recognized CompTIA AI Essentials and CompTIA AI Prompting certifications, directly to schools, workforce centers, and employers through two self-contained mobile training units.







This project will advance six opportunities in Talent Development and two in Grow Existing Business.

#### *Expanding GO TEC Career Pathways in Region 9*

- **Project Goal(s):** To expand the pool of qualified workers by increasing career exploration opportunities in targeted industries in GO Virginia Region 9 by creating Career Connection labs and teacher training as a part of the GO TEC initiative.
- **Project Description:** Add new career connection labs in all the middle schools in counties of Albemarle, Greene, and the City of Charlottesville. Modules include: IT Coding & Networking, Automation & Robotics, Precision Machining, Electrical Engineering, Mechanical Engineering, Manufacturing Engineering, Metrology, Biotechnologies, and Welding. The applicant is partnering with local employers to offer facility tours and deepen students' career exposure. Each module introduces students to career pathways tied to local employer needs, such as biotech lab skills, financial analytics, food production processes, IT systems, and advanced manufacturing.
- **Committed Outcomes:** Train 3,126 students; implement 7 new programs

- **Project Goal(s):** The Venture Central Food & Beverage Accelerator addresses a documented economic development gap in GO Virginia Region 9 where 92% of regional food and beverage

(F&B) manufacturers remain under \$1M in annual revenue, limiting their ability to create higher-wage jobs and expand traded-sector activity despite proven products/market demand. This implementation grant builds on a GO Virginia-funded planning grant to establish Virginia’s first F&B production accelerator, designed to catalyze growth by strengthening R9’s priority traded-sector cluster.

- **Project Description:** The project will serve established F&B manufacturers through annual accelerator cohorts supported by 1:1 consulting and resource connection. Participating firms will be Region 9 based packaged F&B manufacturers with demonstrated product-market fit and readiness to scale, generally generating \$100K+ in annual revenue. Accelerator activities include: strategic coaching, expert consultation network, direct industry connections, peer connections and cohort learning.
- **Committed Outcomes:** 10 jobs, 16 businesses expanded, 16 businesses served, \$150,000 total capital raised by businesses served

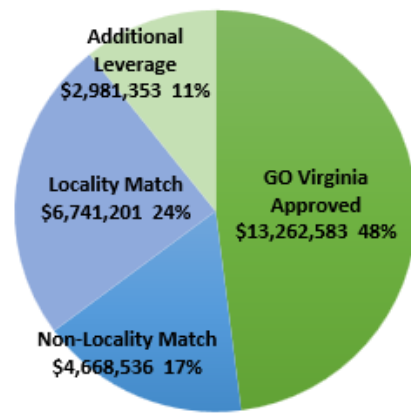

- **Project Goal(s):** Implement an innovative regional workforce initiative that will bring artificial intelligence training, certifications, and career pathways directly into communities across GO Virginia Regions 6 and 9. This project addresses gaps identified in the AISLA report.
- **Project Description:** 80 mobile AI workshops will be delivered across schools, workforce centers, and rural communities in Regions 6 and 9 through two mobile AI units. Each session will utilize CompTIA and AI.edu based curriculum, providing participants with applied training in artificial intelligence fundamentals, ethics, data literacy, and responsible AI use. Workshops – lasting approximately 4 to 5 hours per session (with three sessions per participant) – will be conducted using the hardware and technology installed on the AI Mobile Unit, including laptops, AI software, and secure connectivity.
- **Committed Outcomes:** 2,080 people trained, 20 businesses served, 280 credentials earned, 1 new program implemented, 100 students completing dual enrollment

**Funding Details, All Projects:**

With the addition of these newly awarded grants, through FY 2026, the Region 9 Council has awarded \$13,262,583 to 35 projects in the Piedmont Opportunity Corridor that will grow the regional economy through target traded sectors. Project teams have raised \$6,741,201 of support from local governments,

Through June 9, 2026

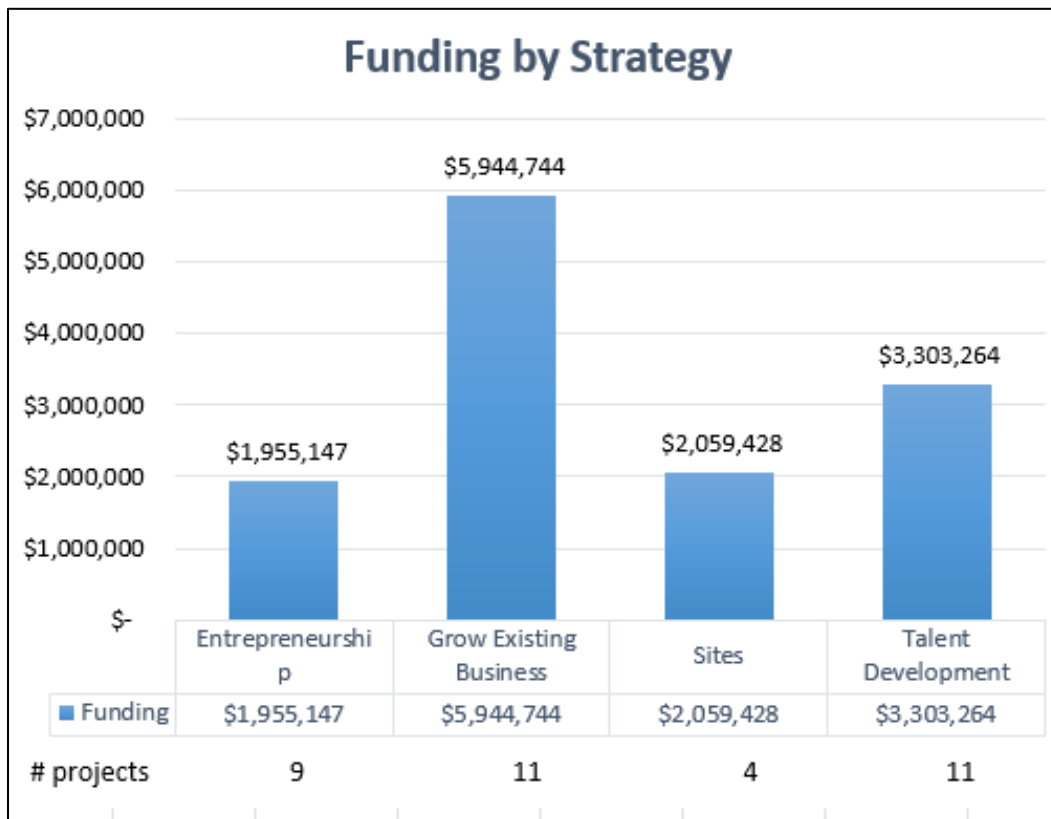

\$4,668,536 from other sources, and \$2,981,353 additional leverage. Funds awarded for Inter-Regional Competitive projects, such as Mobile AI Unit, are not included because the fiscal and administrative responsibility is led by another region.

The following chart shows how awarded grant funds are

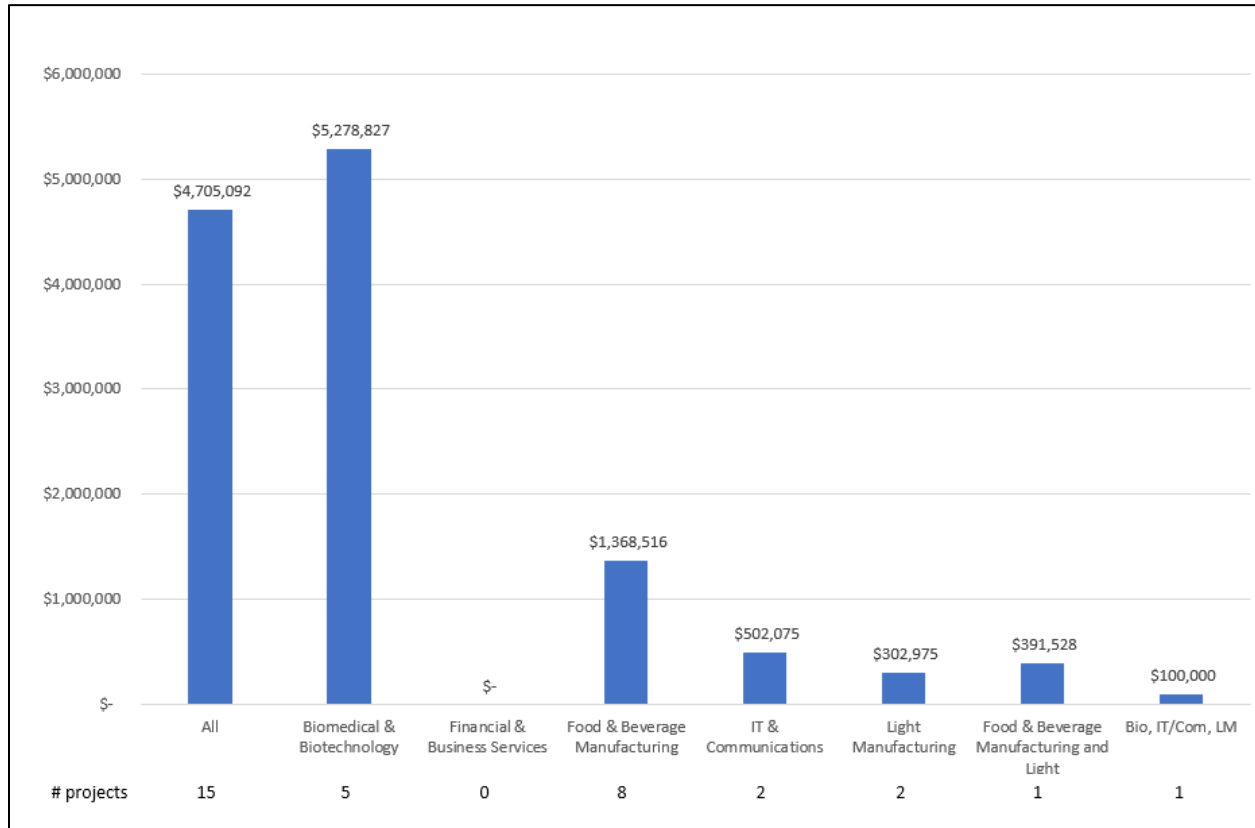

### REGIONAL COLLABORATION & PARTNER SUPPORT

Developing projects requires significant effort in collaboration building. The Council has engaged either directly or through projects with at least 166 partners including: 98 businesses, 15 education institutions, 16 government entities, and 37 other non-profits or stakeholder organizations. A list of those organizations is included at the end of this report.

In addition to grant development, the Region 9 Council and staff have engaged in various other activities:

1. Awarded 102% of the \$1,000,000 FY 2026 Per Capita Allocation (including annual and returned project funds). All Localities engaged.
2. Initiated and internally managed the 2025 Growth Plan publication.
3. Participated in Regional Council Chair meetings hosted by DHCD.
4. Participated in workgroups and interpreted findings of the AI Landscape Assessment report; created grant opportunities to address regional vulnerabilities.
5. Hosted 5 Council meetings and 10 Committee meetings.

6. Supported developing projects from findings of the Comprehensive Economic Development Strategy (CEDS) reports with both the Rappahannock Rapidan Regional Commission (RRRC, PD-9) and the Thomas Jefferson Planning District Commission (TJPDC, PD-10).
7. Served on grant Advisory Committees for BioBridge TPI, Food & Beverage Business Accelerator Planning Grant, and Wine Industry Implementation Grant projects.
8. Created new Council Member Manual.
9. Participated in monthly GO Virginia Organization Support meetings.
10. Chair attended the GO Virginia Board Retreat in Richmond.
11. Attended Project VITAL partner project meeting in Roanoke.
12. Participated in DHCD Policy and Outcomes Feedback Sessions.
13. Attended Virginia Economic Developers Association (VEDA), Charlottesville Business Innovation Council (CBIC), CvilleBioHub, Tom Tom and other community events.
14. Collaborated with peer regions in sharing knowledge to help drive project pipelines statewide.
15. Project site visits including Council members.

## OUTCOMES AND IMPACT

For the region to be successful, target industries must grow their employment base, expand within the region, and attract more related businesses or supply chain. The goal is to achieve growth of target sector employment. The goal can be accomplished by supporting site development, talent and workforce program delivery, and enhancing the entrepreneurship ecosystem of these sectors.

In the 2025 Growth Plan, the Council decided to track the following metrics in the Annual Report as a further metric to evaluate success. Related data is also provided.

As indicated by the table, all target sectors had wage growth, and all but Light Manufacturing had employment growth.

The 2025 Growth Plan did not identify new target sectors. Initiatives relating to the growing Defense and National Security sector are being closely monitored, because other regions have had success integrating related industries within their grant opportunities. Implementation initiatives out of the Innovation Corridor Strategic Roadmap Planning grant are expected to propose strategies within this sector.

**Committed Outcomes:**

The benchmark for the GO Virginia program is Average Annual Wages as measured in the first quarter (Q1) of each calendar year and sourced from Chmura JOBS EQ. As noted below, as of 2025Q3 Average Annual Wages in Region 9 are \$65,785 and \$75,076 in Virginia. Average annual wages per worker increased 2.7% in the region over the preceding four quarters as compared to 5% for Virginia.

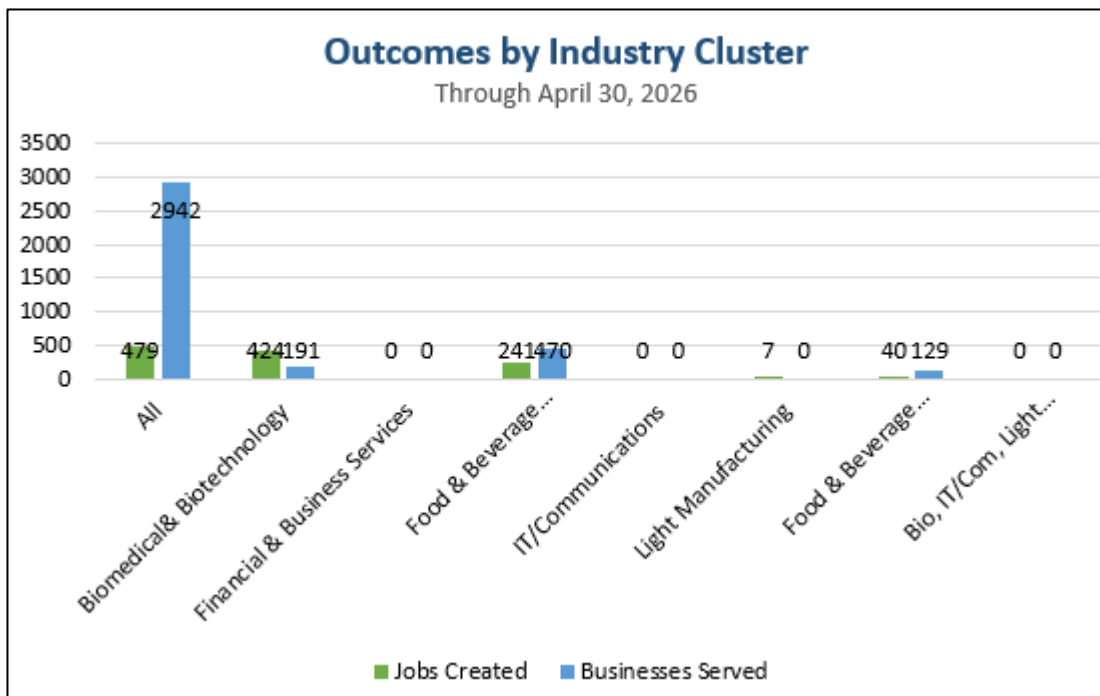
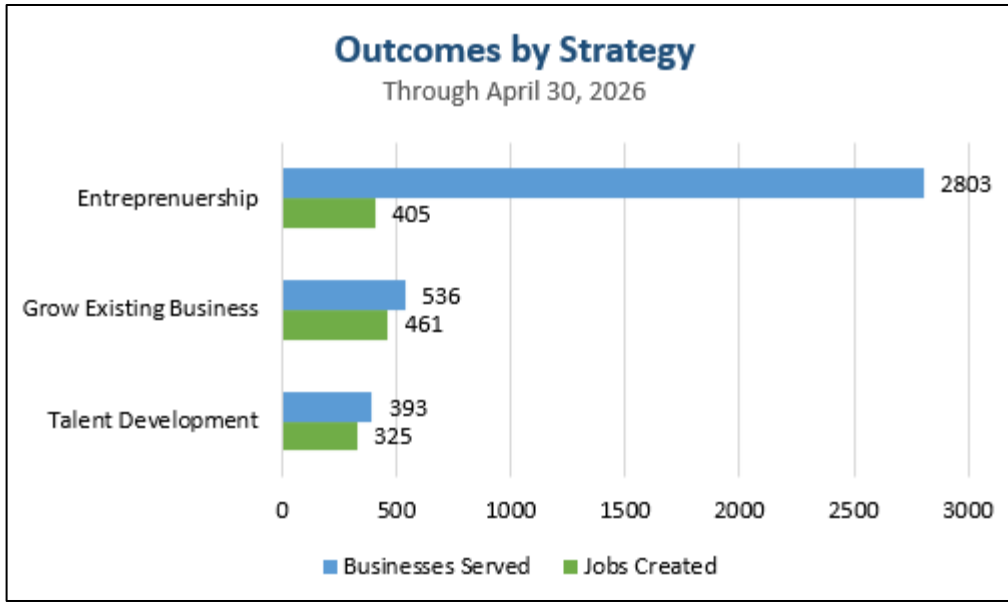

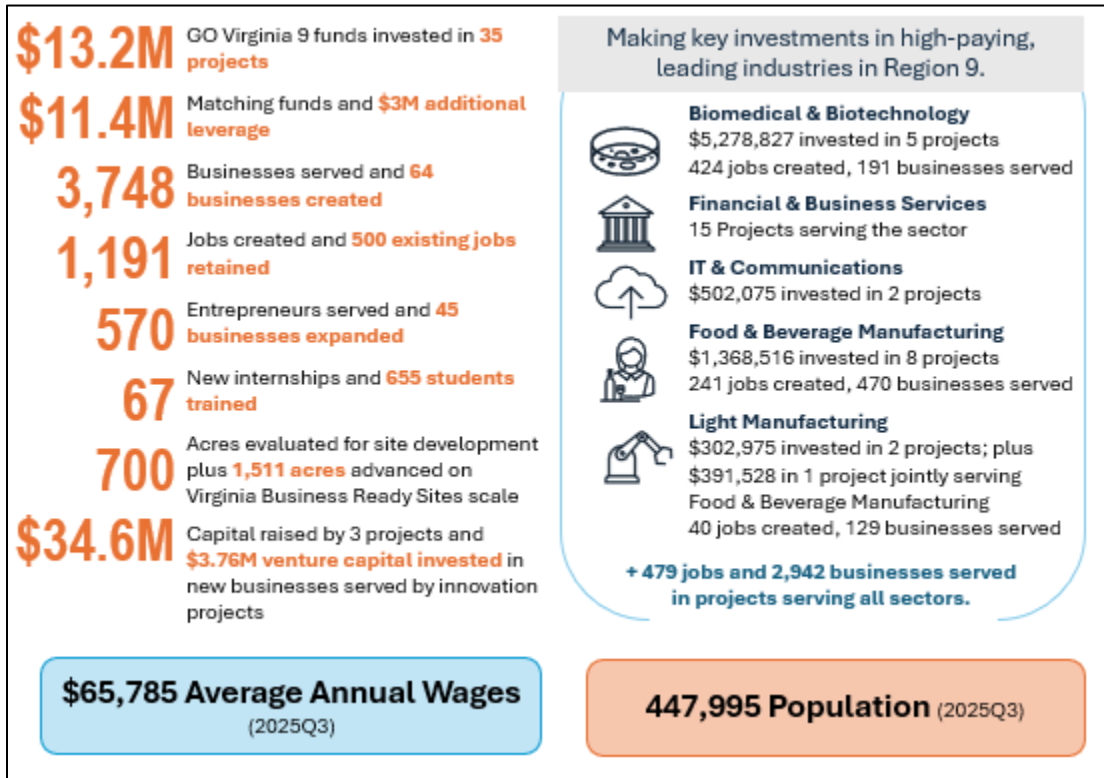


## COMMUNICATION AND OUTREACH

The Region 9 Council website, [www.GOVirginia9.org](http://www.GOVirginia9.org), is the primary resource for stakeholders. Regional staff also amplify updates through email lists, newsletters, and LinkedIn. The Region 9 Linked In page continues to grow and now has 532 followers.

In FY 2026, Region 9 staff continued to market the GO Virginia program and worked hard to support active grant leaders. Staff often went to stakeholder meetings and outreach events. The Region 9 staff also stayed in touch with regional economic development partners to learn about their priorities and to explore ways to work together.

## PROJECT PIPELINE

During FY 2026, staff invested considerable time cultivating projects and engaging stakeholders. Staff support project teams by joining grant advisory committees and regularly updating economic development leaders about the pipeline to manage potential match commitment requests.

In the coming year, the Council expects to support and review proposals as follow up projects to planning grants. Planning grants have proven to be critical in advancing most of the successful catalyzing projects in the region. Through planning grants, plans can be validated, relationship, funding and partnerships solidified to a degree that de-risks an implementation grant where outcomes are required. As such an important precursor, the region tracks works closely with applicant teams to deliver solid reports that are likely to lead to implementation grants.

Five planning grants active in FY2026 generated reports, two led to a subsequent implementation grant awarded within the year, two projects are expected to submit implementation proposals in FY2027, and one proposal was not advanced by Region 9 Council. Additionally, staff and council members served in workgroups related to the Virginia AI Landscape Assessment report.
